WHAT WE DID

“STAMP OUT HUNGER” FOOD DRIVE

Every May as part of the National Association of Letter Carriers’s “Stamp Out Hunger” Food Drive, people across our community leave bags of food by their mailbox. Denton County letter carriers retrieve this food and bring it to the Denton Community Food Center, where United Way of Denton County volunteers unload their trucks and store the food to help families who would otherwise go hungry. In 2015, “Stamp Out Hunger” collected 77 million pounds of food to help hungry families nationwide!

On March 2nd, in honor of Theodor Seuss Geisel’s birthday, more than 200 community members visited elementary schools around Denton County, volunteering to read Dr. Seuss books to children, then leading them in classroom activities!

VOLUNTEER INCOME TAX ASSISTANCE

By filing federal income tax returns free of charge, our volunteers brought a record \$1,852,355 in refunds back into Denton County while saving local taxpayers \$285,120 in tax preparation fees.



MAYOR’S SUMMER YOUTH JOBS PROGRAM

In cooperation with the City of Denton, the Denton Chamber of Commerce and Denton ISD, we piloted a Summer Youth Jobs Program that put graduating high school students to work. Over the summer of 2015, students learned interview skills, practiced good workplace habits, and prepared to enter the workforce.

TINY LIBRARIES

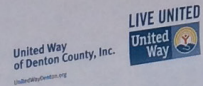
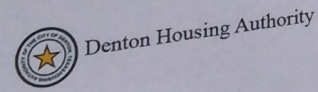

Under the direction of the State of Texas, United Way of Denton County runs the Texas State Employee Charitable Campaign (SECC), the only payroll deduction campaign authorized at state agencies across Cooke, Denton, Fannin, Grayson and Montague counties.

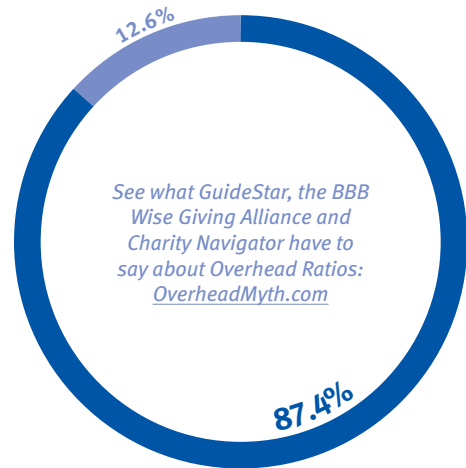
