Welcome & Consideration of June Minutes

Chair Mayor Watts called the meeting to order at 8:05 a.m. He requested a motion to approve June meeting minutes.

Motion: Councilman TJ Gilmore 2nd: Chief Lee Howell Motion was approved.

2017-2018 DCHLT Officers

Mayor Watts presented the 2017-2018 slate of officers recommended by the Nominating Committee:

Chair – Mayor Chris Watts Co-Chair - Chasz Parker Secretary - Councilman TJ Gilmore

He requested a motion to accept the recommended 2017-2018 slate of officers.

Motion: Commissioner Bobbie Mitchell 2nd: Valerie Foster Motion was approved.

Emergency Solutions Grant (ESG) Update

Dani Shaw provided an Emergency Solutions Grant (ESG) update. She reviewed final score submission information, the ESG application and award approval timeline, and implications for Denton County's Housing Crisis Response System.

Last year's ESG Collaborative application ranked 8 of 16, and this year ranks 3 of 19. There are places within the application the collaborative may lose points (the Texas Department of Housing and







Community Affairs utilizes a self-score application process), but at this point in time the collaborative remains cautiously hopeful about its placement. The collaborative consciously lowered the number of people it committed to serving in light of current capacity, realizing that the need will remain greater, but increased accurate data on households served will allow for concrete applications for increased funding regarding ESG and other grant funding.

The current ESG application is for 2 years of funding (2017-2019).

Workgroup Updates

Data Workgroup

Courtney Cross provided an update on the Data Workgroup. The workgroup is finalizing the Denton County Coordinated Entry Policies and Procedures for final approval by the Texas Homeless Network. Backbone support developed an 'Eligibility Matrix' with feedback from the workgroup. This is a tool for Front Door assessing providers to be able to determine best referral options and availability of resources. This will be available on UWDC website with hyperlinks to various housing interventions. Additionally, the workgroup has finalized its prioritization standards, and backbone support is currently assisting agencies in incorporating these standards into their daily operations.

Use of the common assessment tool known as the VI-SPDAT has increased by over 1000% in 2017. These are usually done once for most people who present at an agency, and are updated periodically if enough time has passed, or if an individual or family's circumstances have changed significantly since their last assessment. As of Q2 2017, we have been able to identify the majority areas of need, which will inform the DCHLT Housing Workgroup as they make policy and funding recommendations.

The workgroup continues its education efforts to promote CE among housing agencies, additional service providers, and the faith and business communities. The next phase of CE implementation includes bringing the Sanger Crisis Center on to HMIS. Additionally, the group continues to develop its data dashboard, working with the Texas Homeless Network and local volunteers to accurately export and analyze our homelessness data.

Housing Workgroup

Terry Widmer provided an update on the Housing Workgroup. The second Denton Supportive Housing Pilot has been housed. We are working with the Salvation Army Shelter to negotiate an extended stay option for pilot participants as they wait for units to become available with Denton Affordable Housing Corporation. We have been able to partner well with Youth & Family Counseling to provide more intensive therapy to participants suffering from substance use disorder.

The workgroup has been able to utilize preliminary data coming from Data Workgroup and CE implementation to determine performance goals as a county, and how we will reach them. The workgroup is planning a Landlord Forum for Wednesday, October 18th. The is to share resources between nonprofit and landlord/property manager communities. The workgroup is also planning a soft-

launch of the landlord outreach efforts they've been developing, closely modeling Austin's homeless coalition's successfully implementation of a similar model. A survey will be administered to landlords and property managers attending the forum to gather helpful information to begin building a landlord database and identify those landlords that would be willing to participate in pilot landlord outreach efforts.

Mayor Watts inquired as to the geographic target of the forum, and Courtney informed him that backbone support is seeking a Corinth location for the forum

Moving forward, the workgroup plans to increase discussion of housing policy and ways in which data from CE implementation and landlord outreach, along with additional research, to develop policy and funding recommendations to the DCHLT.

Workforce Development Workgroup

Courtney Cross informed the group that stakeholders were being contacted, and that the Workforce Development workgroup will meet the last week of September 2017.

Community Conversations Workgroup

Courtney informed the group that backbone support continues to meet with interns and volunteers to develop information and conduct feedback sessions throughout the community.

Denton County Homeless Coalition Update

Courtney Cross provided the Denton County Homeless Coalition update. Councilmen TJ Gilmore and Neil Ferguson attended the August General meeting in Lewisville. A subcommittee is developing the framework for the approved 'Barriers Fund', as well as direct donation options. Planning for the 2018 Point-In-Time (PIT) Count will begin August 14th.

Backbone Support Update

Courtney provided an update of her presentation to Denton City Council, requesting sustained support of the DCHLT backbone support position, as well as CE and landlord outreach initiatives. Council will provide final approval in September.

Courtney and Dani will present to the Denton Main Street Association in August to provide information and solicit support for homelessness initiatives through the homeless coalition's Barriers Fund. Councilman Gilmore will connect Courtney with the Main and Mill Historic District Association in Lewisville.

New Business/Public Comments

The Chair made a request for any new business.







Roy Metzler informed the group that the Monsignor King Outreach Center passed inspection, and will host a grand opening with tours August 28th. Capacity will increase from 40 to 95 beds (with the plan to initially expand to 60), and the shelter will go from one working shower to twelve.

Brenda Jackson informed the group that Our Daily Bread is celebrating 17 years and 800,000 meals served.

Chris Martin notified attendees of the Denton County Homeless Veteran Stand Down October 26th.

Commissioner Bobbie Mitchell mentioned her discussions with the Denton County Transit Authority (DCTA), and says they are willing to negotiate a stop with the Monsignor King Outreach Center.

The meeting was adjourned by consent at 9:00 a.m.

To kick off the meeting the group reviewed and provided feedback on the 'side door' infographic that will help faith based organizations and non-HMIS users connect people experiencing homelessness to the Coordinated Entry Process.

The group also reviewed the Denton County Coordianted Entry Eligibility and Priortiy Matricies. These tools are used by Front Door and Receiving Agencies to make appropriate referrals that are available in the community and to prioritize households into housing/ assistance based on their vulnerability and needs. Afterward, the workgroup broke off into teams to complete a case study activity that provided an opportunity for everyone to get more familiar with the matricies and how they are used.

Workgroup member guests, which included all HMIS participants, met to discuss existing data quality and review the Denton Coutnty HMIS Data Improvement Plan. The group kicked off the meeting reviewing the monthly HMIS report which contains data of the number of people on the Housing List, identified housing need, and how many people have been housed. Improvement areas identified are making referrals within the HMIS; following up referrals with a phone call or email to the Receiving Agency; and updating household's housing status after receiving assistance.

The group discussed the anticipation of ESG funding and what reporting changes must be made within the HMIS to reflect how effectively the grant is being used to get people housed. Afterwards the group reviewed the Denton County HMIS Data Improvement Plan. This plan outlines steps that HMIS users shold make to ensure the best possible data is collected.

Lastly, the group went over changes in the HMIS that will be made effective on October 1st.

This tool will be used by Front Door Agency staff when ready to make an appropriate referral within the CE workflow. Illustrated below are possible recommended housing interventions and available community resources.

Recommended housing interventions may not exist; this will require assessors to record any unmet needs. Once staff memeber makes an appropriate referral within HMIS, they will warmly handoff the household to the

Receiving Agency by phone or email. This Eligibility Matrix will be updated frequently to reflect available funding and capacity. Referrals to Emergency Shelter are possible and likely when recommended housing interventions lack vacancy or funding. Assessors will continue to make the recommended housing referral before referring families to an Emergency Shelter.

Front Door - A designated location where individuals and families experiencing homelessness undergo a common assessment process to quickly and equitably gain access to available community resources.

Receiving Agency - Receive housing referrals through HMIS from Front Door agencies and provide housing and/or funding to stably house qualifying households when available and if not, record unmet needs

Diversion - A tool used to assist households seeking housing outside of an emergency shelter by helping them identify immediate alternate housing arrangements, and if necessary, contacting households with services and/or financial assistance to help them return to permanent housing.

- * RRH Rapid Re-Housing -A housing intervention that provides medium to long-term housing to bridge households from homelessnes to permanent housing.
- * PSH Permanent Supportive Housing A housing intervention that provides long-term rental assistance along with intensive wrap-around services to chronically homeless households that could not independently support themselves otherwise.
- * ES Emergency Shelter Provides temporary shelter to households experiencing a housing crisis while more permanent housing solutions are being secured
- * TH Transitional Shelter Medium-term housing intervention where households experiencing homelessness or fleeing domestic violence may stay and recieve supportive servicesthat enable households to move into permanent housing

DENTON COUNTY COORDIANTED ENTRY PRIORITY MATRIX

This tool will be used to assist Recieving Agency staff when ready to select a household from the Housing Priority List. Highest scoring families have first priority to available housing. In the case of multiple households possessing the same VI-SPDAT score, this Priority matrix will be utilized to objectively select the household with the highest vulnerability and most severe service needs.

In August, the Housing Workgroup attempted to begin setting benchmark system performance goals for the Denton County Housing Crisis Response System. After extensive discussion, it was decided that backbone support would conduct additional research and bring recommended benchmarks back to the workgroup. Backbone support is currently working with the Texas Homeless Network to determine a way to accurately extract this data to inform future goal setting.

The group also began preliminary planning to Landlord Outreach initiatives, and determined a date and planning committee for a Denton County Landlord Forum. They reviewed the framework for a landlord outreach model that has been successfully implemented in Austin, Texas.

Backbone support met with Jeff Coffey and Terry Widmer outside of normal workgroup hours to continue to develop a Landlord Outreach framework to soft launch at the Denton County Landlord Forum set for Thursday, October 19th at CoServ in Corinth, Texas.

In September, the workgroup was joined by phone by Bree Williams, with Austin's Ending Chronic Homelessness Organization (ECHO), to obtain further feedback regarding their experience implementing this initiative. Bree provided insightful feedback and engaged in discussion around funding sources and scale of programming given their community's size and homeless population.

DCHLT WORKFORCE DEVELOPMENT WORKGROUP

Meeting Summary – Thursday, September 28, 2017

Attendees: Karmen Rubin (Goodwill Industries of Fort Worth), Lauren Lay (Goodwill Industries of Fort Worth), Chris Marchbanks (Goodwill Industries of Fort Worth), Alicia Froidl (United Way of Denton County), Roxanne Del Rio (North Central Texas College), Mathew Cantrel (United Way of Denton County) and Courtney Cross (United Way of Denton County)

Courtney Cross (UWDC) debriefed the group on the origins of the workgroup, which was created to ensure the Denton County Homelessness Leadership Team's efforts to address homelessness and housing insecurity are in alignment with the work of additional organizations working to meet the income and workforce needs of the Denton County community.

The group reviewed the need for a tool to streamline referrals to workforce development opportunities by case managers working with individuals experiencing or at-risk of homelessness. Backbone support presented a table of background research on existing workforce development opportunities, along with a Coordinated Entry Eligibility Matrix intended to assist case managers making referrals to housing. The group provided feedback on ways to utilize the research conducted to compose a helpful tool.

Attendees primarily consisted of organizations on the receiving end of referrals, and the group agreed the need to engage referring agencies in future development and feedback meetings. See below for additional feedback regarding improvement of future tools:

- Categorize workforce development opportunities by barriers clients may be facing (education level, criminal background, immigration status, immediacy of need, etc.)
- Elaborate on Program/Resource descriptions to include as much information as possible to ensure appropriate referrals
- Include supplemental materials detailing access to supportive services that would contribute to an individual or family's ability to maintain or increase their income (childcare, transportation, etc.)

Workgroup Summary
