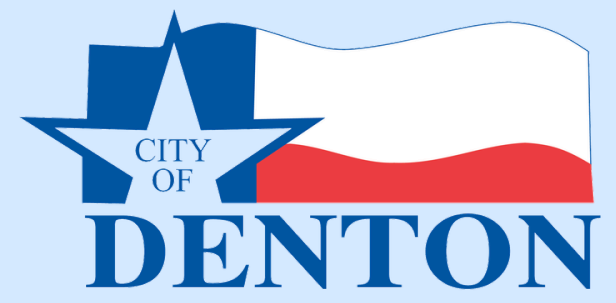

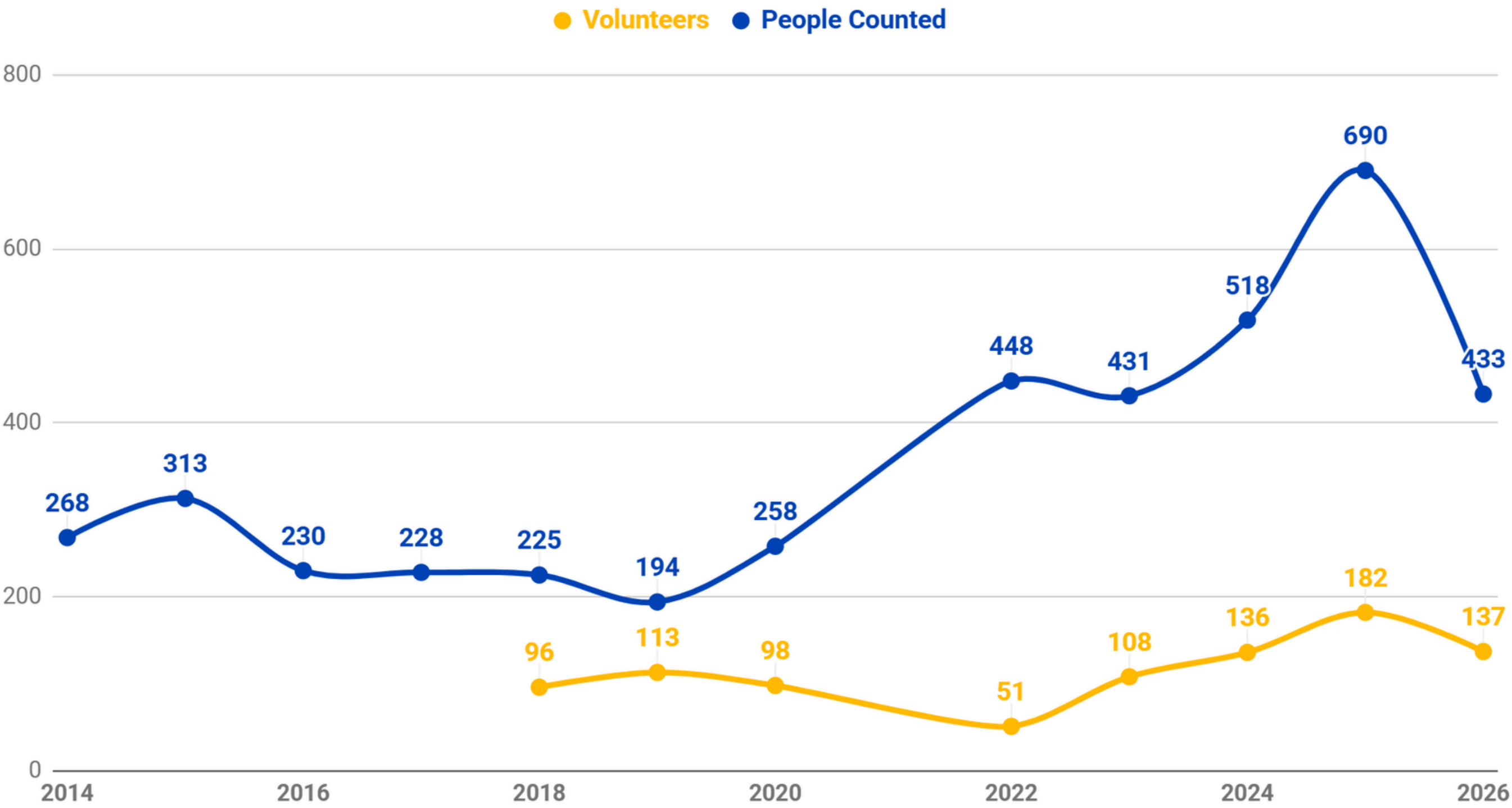

Point-in-Time Count Through the Years



Change in Persons Surveyed: -257 person decrease (~37%)

Volunteers: -45 volunteer decrease (~25%)

*In 2021, only a shelter count was conducted due to COVID-19. The sheltered total was 176.



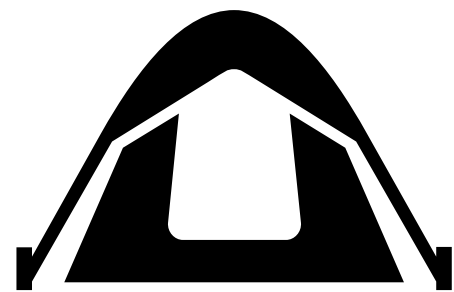

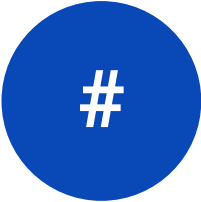

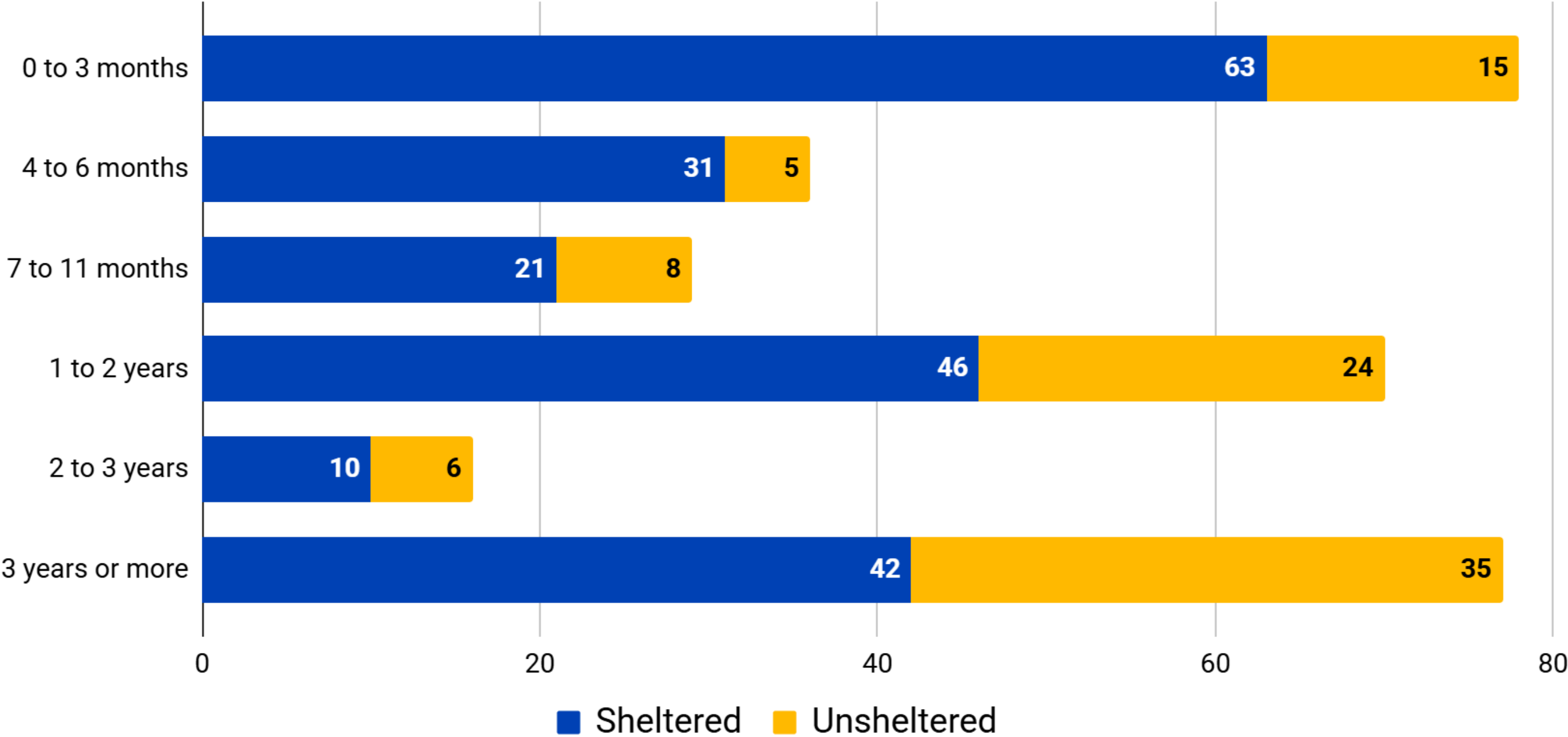

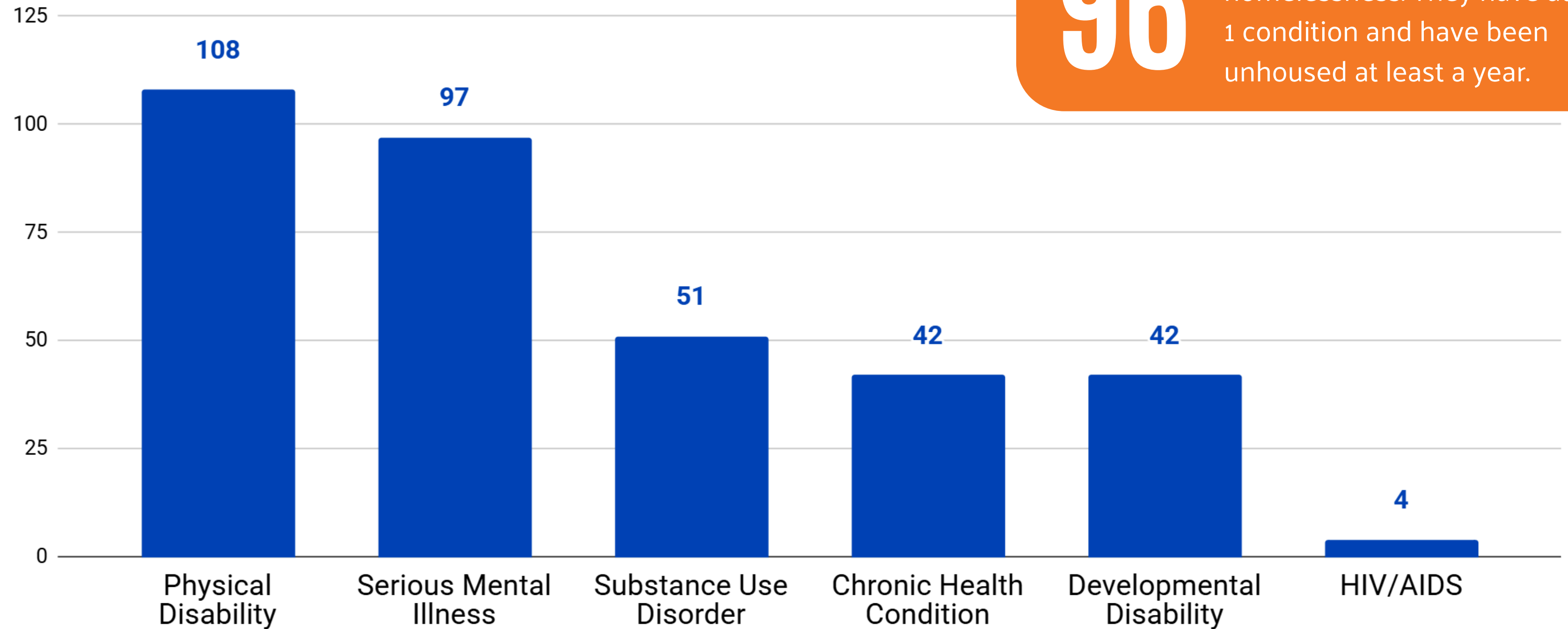

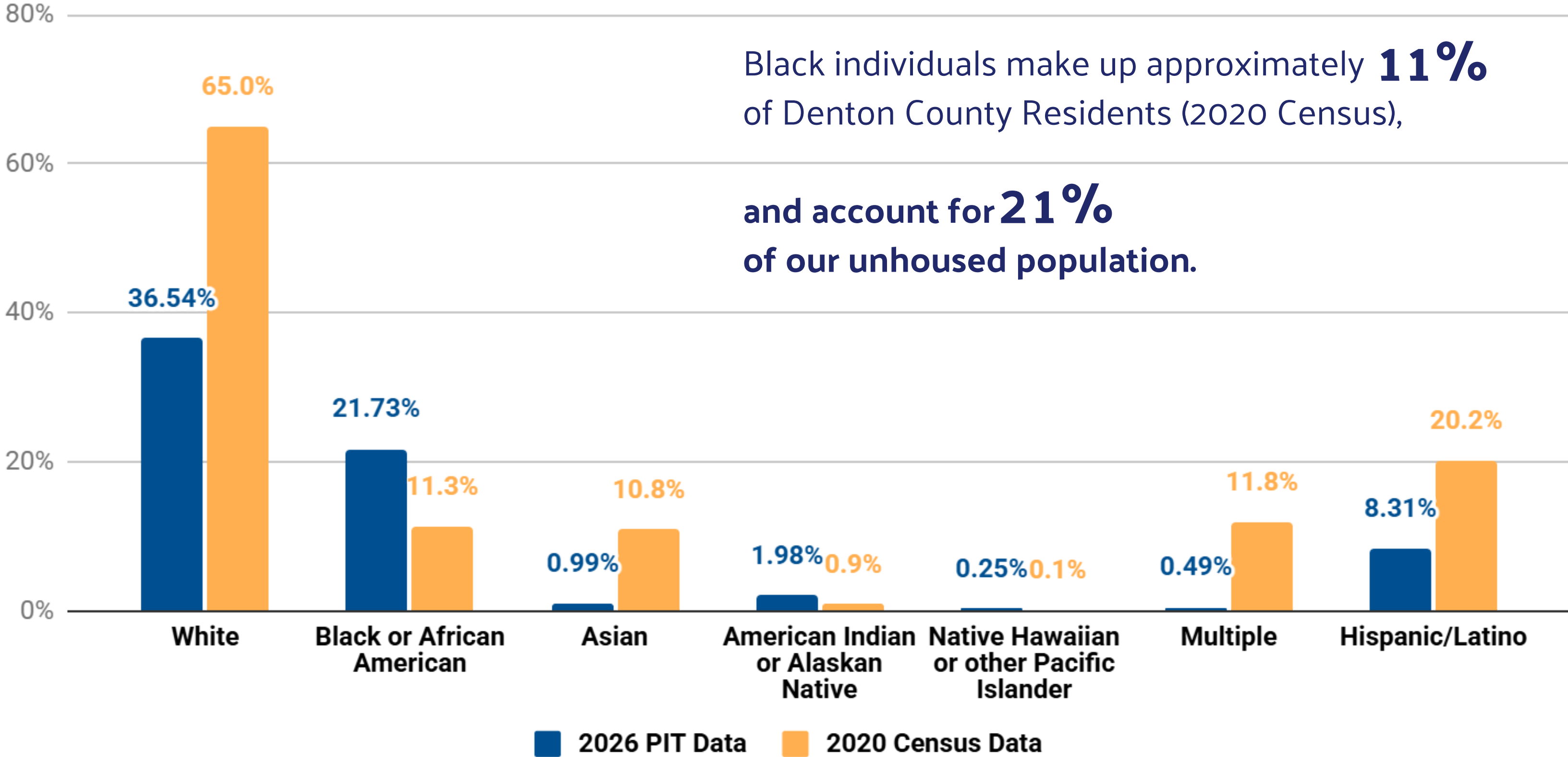

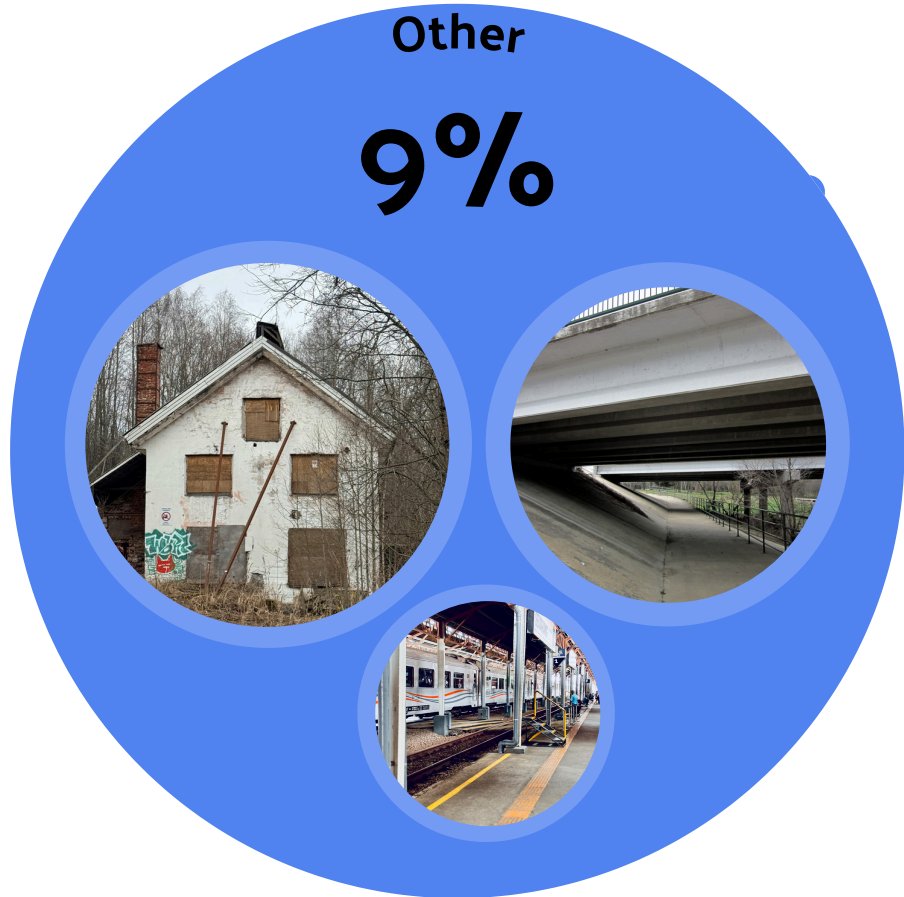

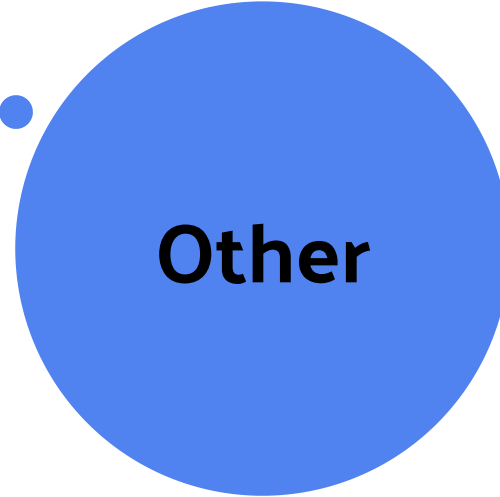

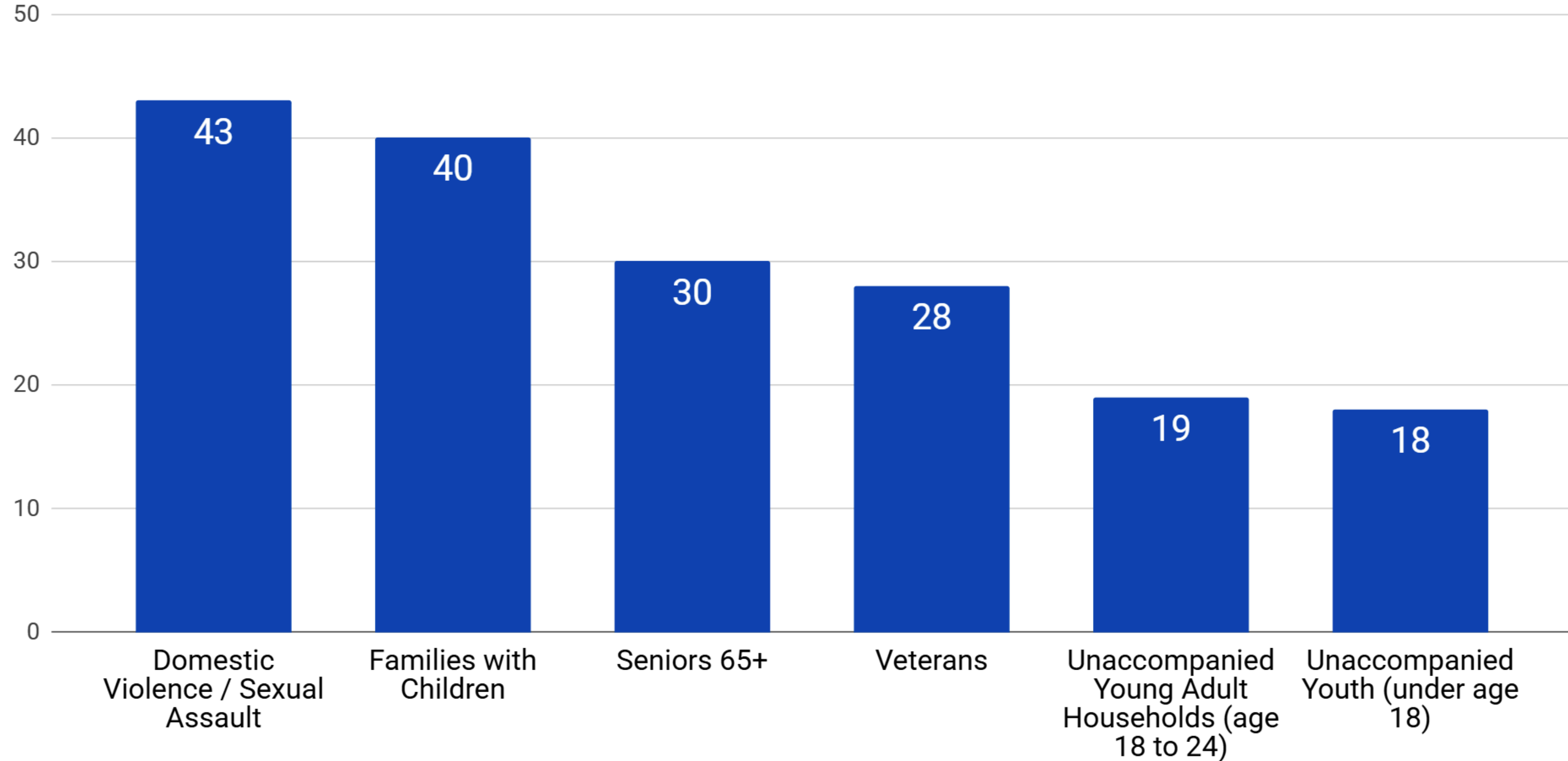

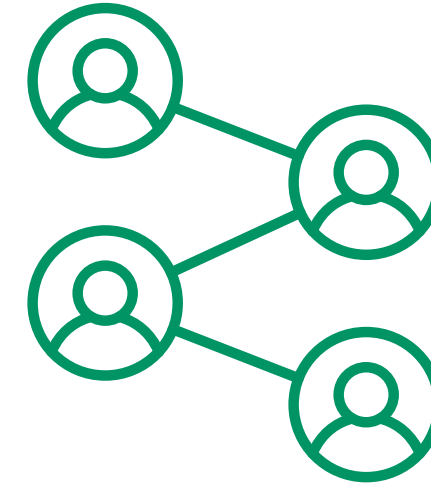

Public - Private Partnerships

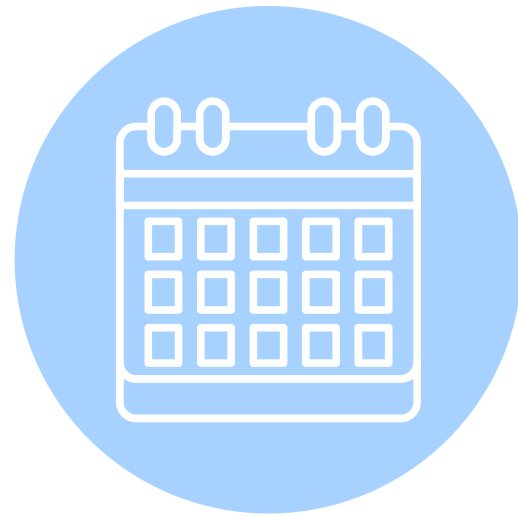
- Increase in housing placements by 10.8% (2024-2025)
- Tenant Based Rental Assistance (TBRA) funding supported an increase in family housing placements
- Increase in landlords opening doors in Denton County, led to housing more neighbors

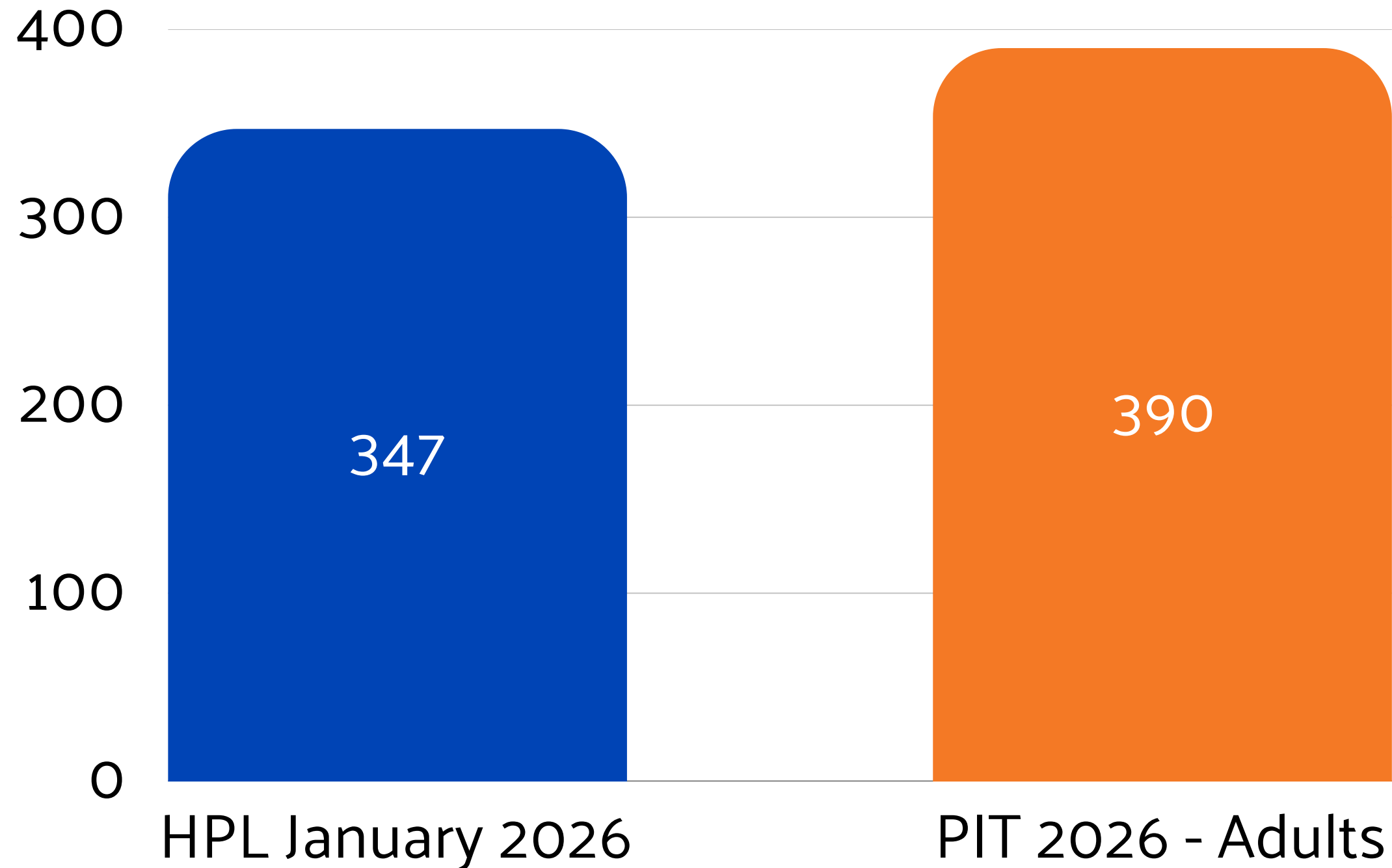

PIT and HPL Data Comparison - 2026

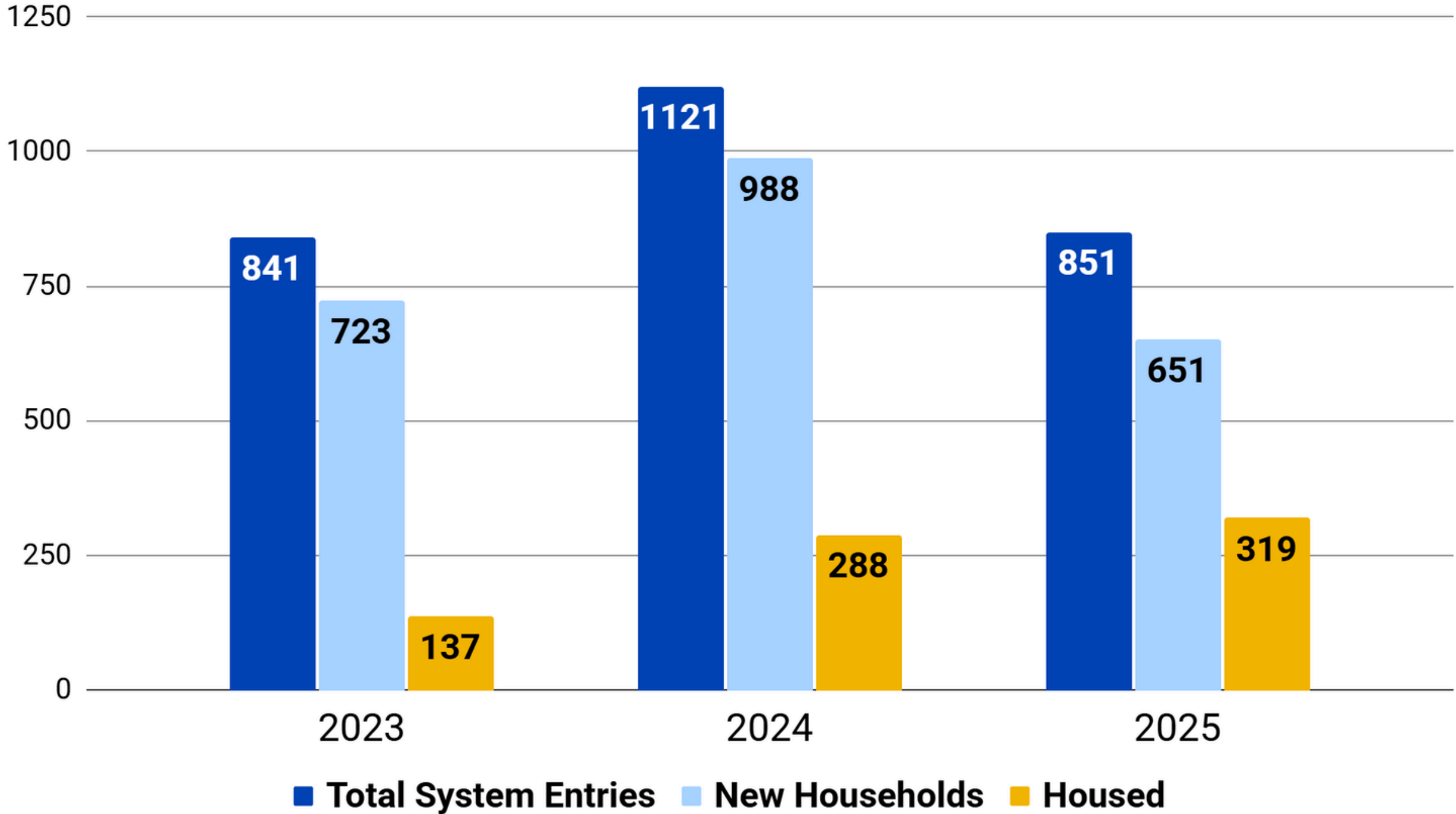


When children are removed from the 2026 PIT Count, the adult total aligns with the January 2026 HPL.

This is because the Housing Priority List (HPL) only includes adults who've been assessed and are actively engaged in services.

Children are counted in the PIT but not listed individually on the HPL.

System Trends



The number of successfully housed households more than doubled, from 137 in 2023 to 319 in 2025.

Improved Housing Rate: The housing rate improved from 16% in 2023 to 37% in 2025, reflecting greater placement effectiveness.

- 2023:** Tenant Based Rental Assistance \$
- 2024:** Housing Connectors + Improved Landlord Engagement Process
- 2025:** Expanded Housing Connectors pilot + Increase in Landlords

- **2001 - 2018:** Denton County Homeless Coalition is an independent community group
- **2019:** Becomes workgroup under Denton County Housing & Homelessness Leadership Team (DCHHLT)
- **2023 - 2024:** Committees under Coalition begin forming, strengthening system needs
- **2025:** Coalition Exploration Committee reviews interest and feasibility of becoming an independent nonprofit. Coalition members vote to move forward & support from DCHHLT provided. To focus on continuing or filling gaps in:

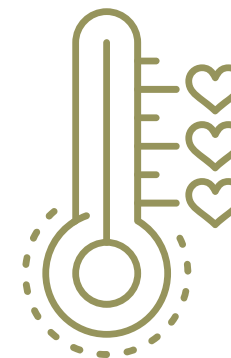
