




OUR COLLABORATIVE INITIATIVES & PROGRAMS



By building strong, inclusive, trusting relationships between Denton County businesses, governments, and nonprofits, our Collaborative Initiatives and Programs aim to tackle complex socioeconomic problems like poverty, homelessness, and mental illness.

We work to improve the quality of life for the most vulnerable among us. We leverage connections and credibility to do the difficult task of making system-wide impact.

ALEXIS DE TOCQUEVILLE SOCIETY

Tocqueville members are local leaders in philanthropy who have contributed \$10,000+ to improve lives.

BACK-TO-SCHOOL PROGRAMS

We coordinate the collection and distribution of school supplies for economically disadvantaged children.

BARRIERS FUND

This fund reduces barriers to housing by increasing resources of nonprofits working with Denton County families to promote housing stability and self-sufficiency.

COMMUNITY GRANTS

We amplify the efforts of highly efficient and effective nonprofits by investing resources to address the most critical needs of Denton County.

COMMUNITY NEEDS ASSESSMENT

We research, collate, and publish full reports every five years to determine Denton County's highest-priority needs. Annual updates assess changing trends.

DENTON COUNTY BEHAVIORAL HEALTH LEADERSHIP TEAM

This Team advocates and facilitates a collaborative person-centered behavioral health system to repair and restore lives.

DENTON COUNTY HOMELESSNESS LEADERSHIP TEAM

This Team fosters an effective and coordinated system of homelessness prevention and intervention.

DENTON COUNTY VETERANS CENTER

We collaborate with local Veteran service providers to maintain a suite of services for our Veterans in need.

EARLY CHILDHOOD COALITION

This Coalition works to engage and empower parents, families, professionals, and communities to provide enriched environments for all children birth - 8 years.

FOOD DRIVES

We coordinate with National Association of Letter Carriers' Stamp Out Hunger and Mayor's Day of Concern for the Hungry to feed local families.

HEALTH FAIRS

We attend and/or host several health fairs to educate the public on health and mental health challenges and resources in our community.

INFORMATION & REFERRAL

We help people in crisis through a local helpline, online database, and local resource directories to connect those in need with service providers in Denton County.

MAYOR'S SUMMER YOUTH JOBS PROGRAM

We partner with businesses to give Denton ISD students valuable work experience and professional development.

NETWORK OF NONPROFITS

We holistically support a network of Denton County's finest nonprofits to increase efficiencies and eliminate redundancies to better meet people's needs.

POINT-IN-TIME COUNT

This annual survey counts Denton County's unsheltered and sheltered homeless on one night to better understand the nature of homelessness.

PROJECT BLUEPRINT BOARD LEADERSHIP TRAINING

We teach local volunteers the skills needed to shape and govern a successful nonprofit board.

SCHOOL-BASED COMMUNITY CENTERS

We partner with schools to bring parenting and employment resources into neighborhoods.

WORKING FAMILY SUCCESS

We help working families increase their earning potential and resiliency through bundled, supportive services.

VOLUNTEER INCOME TAX ASSISTANCE (VITA)

We provide free tax preparation to low and moderately-low income families.


VETERANS COMMUNITY NAVIGATOR
